Terms & Conditions: -

1. You must quote for all the items under this request. Price quotations will be evaluated for all the items together and contract awarded to the firm offering the lowest evaluated total cost of all the items.

2. The bidder's bid for the items , as selected to bid, must be for its latest version only

A certificate on company letterhead, stating that the bidder hasn't been blacklisted by any institution/ organization/ society/ company of the Central / State Government ministry/department, or its public sector organizations during the last three years with company stamp and signed by authorized signatory should also be submitted
- The bidder should have adequate facilities, trained manpower and staff for Installation, commissioning and providing maintenance support service after the sales of the equipments in India.
- 6. The Bidder will deploy their own manpower for the installation / integration of the equipments and should not be outsourced to any third party.
- 7. For a bidder, who has submitted the tender bids, it will be automatically assumed that he had accepted all the terms and conditions of the tender
- 8. You shall submit only one set of quotations. Your quotation must be typed or written in indelible ink and shall be signed by you or your authorized representative. Without a signature in your quotation, your quotation will not be considered further.

09. Eligibility for Bidders to Qualify Technically:

- A) The bidder must have to submit their registration or experience certificate of last three financial years of Satisfactory Supply of similar nature to some Govt./Semi Govt. Organization or State/Central PSU.
 - B) Copy of GSTIN of Bidder.
 - C) Copy of PAN of Bidder.
 - D) Non-Refundable Tender Document Cost in the Shape of Demand Draft of Rs. 300/- (Rupees Three Hundred only)
 - E) Earnest Money as prescribed in the Tender Document. All the registered Local Micro & small Scale enterprises or Industrial units registered with Store purchase organization or DGS&D or NSIC are exempted from EMD on submission of Valid certificate.
 - F) Undertaking (Annexure-I)

10. Preparation of Bids and Submission:

- A) The tender should be submitted along with the registration or Experience Certificate, Copy of GSTIN, Copy of PAN, Tender Document Cost, Earnest money and **Financial Bid** (in form given in Annexure B)
 - B) Separate envelope should be used for Technical Bid as well as for financial Bid. The word "TECHNICAL BID/ FINANCIAL BID with due date of opening shall be

prominently marked on the top of envelope and both these sealed envelopes (Technical Bid and financial bid) should further be put in a bigger envelope duly sealed and super scribed properly. - C) The rates should be quoted in Financial **Bid** only **both in words and figures**. Prices shall be quoted in the currency **Indian National Rupees** only.
- D) The rates quoted should be F.O.R. Govt. Industrial Training Institute, Bangana, District Una (HP) means in the concerned area/ Lab/ Workshop / Store of the Institution including testing commissioning, installation and Training whenever required.

E) All documents submitted must be dully signed by the bidder.

11. Evaluation of Tender:

A) The Technical Bids will be opened first on 05/07/2021 at 03:30 PM in the presence of bidders or their authorized representatives who may want to present . The financial Bid will be opened only after scrutiny of technical bid and technical evaluation of Tender . In case the office is closed on this date due to any of the reasons or it is not possible for us to open the quotations on this date because of any of the reasons, the quotations will be opened at 03:30 PM on the next working day

- B) Decision of Tender Opening Committee will be final and binding upon the bidders.
- C) Offers determined to be substantially responsive to the technical specifications will be evaluated by comparison of their prices. An offer is not substantially responsive if it contains material deviations or reservations to the terms, conditions, and Specifications in this tender, and it will not be considered further. The 'Purchaser will evaluate and compare only the quotations determined to be substantially responsive. In Evaluating the quotations, the 'Purchaser will adjust for any arithmetical errors as follows:

(a) Where there is a discrepancy between amounts in figures and in words, the amount in words will govern;

(b) Where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern and

(c) If a Supplier refuses to accept the correction, his quotation will be rejected

12. Award of Purchase Order:

- A) The award will be made to the bidder offering the lowest evaluated price and that meets the required standards of technical and financial capabilities.
- B) VALIDITY OF THE OFFER: Your quotation(s) should be valid for a period of Sixty (60) days from the deadline for receipt of quotation(s)
- C) The successful bidder will be notified by the Institution. The successful bidder shall submit the **performance security @ 3%** of the contract amount (including taxes as applicable) in the shape of FDR pledged in the name of Member Secretary cum Principal Govt. ITI Bangana, within 21 days of notification of successful bidder. The performance security must be valid for warranty period + 60 days
- D) If you withdraw your quotation during the validity period and/or refuse to accept the award of a contract when and if awarded, then earnest money will be forfeited and the contract will be awarded to the next firm offering the lowest evaluated total cost of all the items (excluding your firm).

13. If felt necessary, the undersigned may ask for a demonstration of the machinery/equipments.

14. The quoted product should not be end of life at the time of bid submission. The support shall be provided by the bidder/ OEM for next three years.

15. Warranty and Support:

The bidder must ensure that the supplied equipment(s)should be maintained for 365 days from the installation / commissioning of all the equipments under the contract. The bidder must provide support for at least five years

- 16. Delivery: FOR Govt. ITI Bangana within 60 days after award of Contract
- 17. **Payment:** 100% Payment of the contract price shall be made upon acceptance of the delivered goods by the Purchaser.

18. Delays in the Supplies and Performance of services:

A. Delivery of the goods and the performance of services shall be made by the Supplier in accordance with the time schedule specified by the Purchaser.

B. Any unjustifiable delay by the Supplier in the performance of his delivery obligation may render the Supplier liable to any or all the

- (i) Forfeiture of its performance security,
- (ii) Imposition of liquidated damages @Rs 100/- per day for the unfulfilled order.
- (iii) Termination of the contract is at the risk & cost of the supplier/contractor.
- (iv) Initiation of any other legal proceedings.

19. AFTER SALES SERVICES: Comprehensive Warranty:

(i) The Supplier shall provide Comprehensive OEM warranty (including labour and spares) for 365 days from the installation / commissioning of all the equipments under the contract. The warranty shall cover the hardware, hardware parts System Software, Labour and including updation /upgradation (free of cost). The supplier of Items shall ensure genuine add-ons items & consumables for the items sold in the state for their own brand.

(ii)

The supplier will provide prompt after sales support and shall attend any complaint not later than 48 hours. The minor and major defects shall be rectified not later than 72 hours. If defect is not rectified within the time stipulated as above penalty as prescribed at clause No. 16 (iii) by the Purchaser will be imposed. However, the penalty in such instances shall not exceed 5% of the equipment(s) cost against a non-attendance/ non-rectification of defects against a service call.

(iii) Imposition of penalty @Rs 50/- per day and penalty shall not exceed 10% of the equipment cost.

20. Jurisdiction/Signing of Tender/Agreement:

Conditional tenders or tenders without EMD will not be entertained in any respect. The undersigned reserves the right to reject any or all of the tenders without assigning any reason. No separate agreement will be made, this tender document will be treated as agreement between both supplier and buyer. In any dispute all the decisions made by undersigned will be full and final and would be binding upon the supplier/bidder. All disputes are subjected to Una H.P. jurisdiction only. All documents enclosed must be self-attested by the bidder.

21. The Member Secretary cum Principal Govt. Industrial Training Institute, Bangana can also appoint a "<u>Negotiation Committee</u>" if required.

22. The award of contract is subjected to the approval of competent authority and availability of fund at Govt. Industrial Training Institute, Bangana District Una, H.P under STRIVE scheme
